







Hi, I'm Andy. I'm one of the owners of Sue's Swim School and the eldest of the 2 brothers that now run it. I spent 11 years as a Primary School Teacher. Within the school I worked in I was PE Co-Ordinator and advisor to schools in our area.

I was often disappointed at the school swimming provision that was offered by councils and local swim schools in the area. In my 2nd year as a coordinator I began to structure my own sessions and deliver them myself (I had qualified as a swimming teacher in 1997).

Nationwide we are seeing some of the lowest levels of children achieving the statutory criteria by the end of KS2, we simply believe this is not good enough, and at no fault of the schools.

In the last 5 academic years, we have achieved over 92% of our swimmers in our school provision reaching the national guidelines with a supporting report that the schools have used in OFSTED and updates explaining what was done to provide the best help they can.

SCHOOL GAMES KITEMARK

Andy worked as a qualified Keys Stage 2 teacher for 11 years. In this time, he worked as a PE Coordinator for 8, in which he took a school with no Kitemark or School Games recognition and reached the Gold Kitemark (the highest at the time) and was one of the first schools to reach it 5 years in a row.
